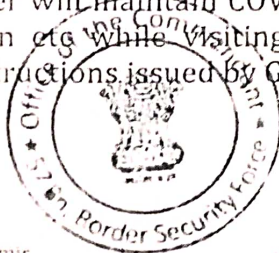

AUCTION NOTICE
