- 2. Quotation will be opened on due date at 1600 hrs at Commandant 184 Bn BSF, POST Serkawn, Distt Lunglei (Mizoram) Pin 796691 in presence of the tenderers or their representatives who may wish to be present.
- 3. The Government of India reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reasons thereof and does not bind itself to accept lowest quotations.
- 4. Participation in this tender is by invitation only and is limited to the selected Procuring Entity's bidders. Unsolicited offers are liable to be ignored. However, suppliers who desire to participate in such tenders in future may bring it to the notice of Procuring Entity and apply for registration as per procedure.
- 5. The bidder should mention whether the tender is a large scale industry or a small scale industry and also attach NSIC/MSE/MSI certificates if any, to the quotation along with registration details.
- 6. After finalization of tender by competent authority, orders for supply / providing of EFC Boat will be placed to tenderer quoting L-1 rate. Before deployment pre-inspection of EFC Boat will be carried out by a Board Of Officers (BOOs) and HPL (Hour per Litre) test of selected Launch will be conducted by BOOs constituted by BSF. Pre-inspection of Boats by the Board will be carried out only once the Performance Security as asked vide clause-15 below is deposited by the successful bidder.
- 7. The Government of India reserves the right to modify the quantity specified in this enquiry.
- 8. The prices quoted should be firm till the supplied are completed. Please quote the rates in words and figures. Rates quoted should be free delivery at destination including all charges otherwise the quotation is likely to be rejected. Prices quoted for free delivery at destination will be given preference. Price quoted should be gross (inclusive of all taxes) and valid for the entire period of deployment for which tender is invited from the date of opening of the quotation.
- 9. Payment of sales tax is primarily the responsibility of the bidder and will not be paid unless the percentage value is clearly mentioned in the quotations. If no indication regarding GST is recorded in the quotation, the GST will be considered as included.

SPECIAL TERMS AND CONDITION FOR HIRING OF LAUNCH

- 1. If Launch man is found using mobile OR is suspicious of passing sensitive information to smugglers / carriers, the tender is liable to be scrapped immediately. A penalty of RS. 10,000/- will also be levied on the Launch owner/firm, for each instance.
- 2. All Launch men must be minimum 18 yrs of age or above as on tender publishing date, should be residents of area at least 10Kms outside the area of deployment for which the bid is being submitted any changes in this list can be made only after approval of Commandant of Bn.
- 3. During HPL (Hour per Litre) / deployment of the Launch, Launch owners shall submit photographs, proof of address (electricity/water bill, certificate from Panchayat with ID card), character and antecedent / Police verification of Launch / Boat man so recommended for operating of Launches / EFC Boats/Tractors.
- 4. Leave of the Launch man/ EFC Boatman / Tractor Driver throughout the year will be managed by the owners by providing suitable replacement from the list of Launch man/Boat man/Tractor Driver initially submitted by the bidders and subject to approval of the Commandant in r/o the residence of the Launch man / Boatman / Tractor Driver.
- 5. Launch number and registration number of Launches should be distinctly marked on Launches.
- 6. For operation/ administrative requirement, deployment of Launch and Launch man will be rotated / shifted from one BOP to another BOP within the area of operation as per Ops /Adm requirement.
- 7. The launch owner will be fully responsible for any damage / loss to their Launches. The repair and maintenance cost shall be borne by the Launch owner at his on cost.
- 8. All Launches should be registered by Inland Water Transport (IWT) Assam and should have the valid fitness certificate for one year w e f Mar 2023 to Feb 2024.
- 9. The rates quoted by intending firm / launch owners must include the launch man salary on daily wages. No boarding/lodging facilities /charges would be provided by BSF.
- 10. The approved firm / Launch owners will have to be ready to provide the Launches on approved rates as per requirement basis throughout the validity period of tender.
- 11. In case of damage/defective Launches, the owner shall make an alternative arrangement else Rs. 1,000/- per day will be deducted as penalty up to 07 days and if the Launches remains defective for more than 07 days without replacement, payment the entire month would be deducted besides including penalty. Penalty for absence of a launch man for one day will be 75% of the cost of hiring of Launch for one day.
- 12. Fuel required for running of Launches will be provided by BSF after conducting HPL test of hired launch after reaching at deployment place. Hence, rates should be quoted excluding POL charges.
- 13. Performance Security of successfully firm shall remain with BSF till completion of hiring period and the earnest money of un–successful firm will be returned after finalization of tender.

- 14. Hiring charges / payment will be made on monthly basis after deduction of penalty charges if any. Hiring charges will not be paid for the period when the Launches remain non operative due to some defect or absence of Launch man.
- 15. BSF will not be responsible for any incident/accident. No claim of any sort of men and materials due to any mishaps / accidents will be entertained by BSF. Full responsibility of any third party claim or by the launch man would lie with the firm and the firm would submit a bond to this effect.
