**Sub :- FILLING UP THE POST OF INSPECTOR (FOREMAN GENERAL),
 SI (FOREMAN PRINTING & BINDING), ASI (COMPOSITOR &
 MACHINEMAN) AND HEAD CONSTABLE (INKER AND
 WARE HOUSEMAN) BY DEPUTATION**

It has been proposed to fill up following vacant Posts at BSF Printing Press located at BSF Academy Tekanpur Distt-Gwalior (MP) on deputation basis.

(a) Inspector (Foreman General)	-	01
(b) Sub Inspector (Foreman Printing & Binding)	-	02*
(c) ASI (Compositor & Machinman)	-	01*
(d) HC(Inker and Warehouseman)	-	01

(*vacancy may increase/decrease).

2. The eligibility criteria for each Post are as under:-

(a) Inspector (Foreman General)

Foreman of Pay Level-6 who had served Central Printing Press, Tekanpur with five years regular service in the grade.

(b) **Sub Inspector (Foreman Printing & Binding)**

- (i) General Central Service, Group –‘B’ Non Gazetted, Non Ministerial (Combatised).
- (ii) Serving Border Security Force personnel in the rank of ASI having six years’ regular service in the pay level-5 and possessing minimum seven years’ experience in Printing and other allied trade

(c) **Assistant Sub Inspector (Compositor & Machineman)**

- (i) General Central Service Group-‘C’ Non-Gazetted, Non-Ministerial (Combatised).
- (ii) Serving BSF Personnel in the rank of Head Constables having five years regular service in pay Level-4 or Constables with Ten years regular service in pay Level- 3 and processing minimum five years’ experience of Printing and other allied trade subject to Qualifying the Trade Test.

(d) **Head Constable (Inker and Warehouseman).**

- (i) General Central Service Group-‘C’ Non Gazzetted, Non-Ministerial (Combatised).
- (ii) Serving BSF personal in the rank of Head Constables or Constables with five years regular service in pay level -3 and processing the following :-
 - (aa) Minimum three and five years’ experience in Printing and other allied trade for Head Constables and Constables respectively.
 - (bb) Must qualify the trade test.

3. The period of deputation including ex-cadre post held immediately preceding this appointment in some other organization or departments shall ordinarily not exceed three years.

4. The terms and conditions of deputation will be governed by the standard terms and conditions of deputations as laid down in the Ministry of Personnel Grievances and Pensions (Department of Personnel and Training) OM No.6/8/2009-Estt (pay-II) dated 17th June 2010 and as amended from time to time. Eligible personnel serving in BSF formation can apply for above posts through their parent Units/HQrs. The eligible candidates, selected for deputation will be appointed initially for a period of three (03) years which could be curtailed/extended, if the exigencies of service so require, subject to the suitability of the individual and his willingness.


5. It is, therefore, requested to forward nominations of eligible and willing candidates alongwith their Bio-Data as per prescribed format as per Appendix-'A' (attached). Disc/Vig clearance certificate, attested photo copies of ACRs for the last five years, willingness certificate of individual concerned and attested photo copy of requisite certificates and Trade/experience certificate to the Inspector General (Adm), Adm Directorate, Directorate General Border Security Force, Block No-10, CGO Complex, Lodhi Road, New Delhi-110003, so as to reach this HQR within 60 days from the date of publication. While forwarding the nominations, concerned **Units/HQrs** may please verify and certify that the particulars furnished by the candidates are correct and that no disciplinary or vigilance case is pending/contemplated against the candidates. It may also be confirmed that in the event of selection for appointment, the individual concerned will be relieved of his duties.
