**Terms & Conditions:-**


1. All interested/authorized bidders can participate in the auction and can bid after depositing earnest money as prescribed.
2. Each bidder will have to deposit Rs. 15,000/- (Rupees fifteen thousand) only as an bid security at auction spot, one hour prior to the auction for participation, which will be refunded/adjusted after finalization of auction on the same day.
3. Each bidder must be in possession of their Identity proof and address proof in the form of Aadhar Card or Election Card or Driving License etc., in original and submit Xerox copy of following documents duly self-attested alongwith earnest money.
  - a. Xerox copy of Aadhar Card or Election Card or Driving License etc., as Identity and Address proof.
  - b. Latest Income Tax return.
4. If any bidder does not submit copy of above documents, he will not be allowed to participate in the auction.
5. All bidders will register their names with the board of officers at least one hour before the auction by producing above documents.
6. The highest bidder will have to deposit earnest money the 25% value of auction at the spot and deposit remaining amount of Auction value prescribed taxes (GST) immediately. No additional time shall be provided to the bidder for by the end of the day upto 1600 hrs.
7. If the successful bidder failed to deposit the prescribed amount instantly, the bid security deposited by him shall be forfeited in addition to initiating all other actions as deemed fit against the bidder. Further, the bid shall be offered to next highest responsive bidder at the risk and cost of the highest bidder.
8. The Commandant of 83 Bn BSF will reserve all rights to accept/reject the bid without assigning any reason what so ever.
9. The decision of the Commandant 83 Bn BSF shall be final in all matters relating to the auction.
10. Other terms & conditions will be announced by the board of officer appointed for the purpose during the auction.
11. The Buildings will be auctioned "AS IS WHERE BASIS".
12. After completion of auction process, the successful bidder shall demolish the buildings, remove the debris and clean Surface in his own expense/ risks within a period of 30 days.

13. The successful bidder shall abide all norms of demolition including the local instructions and undertake the demolition work of the building cautiously. The bidder shall not cause any damages to the other installation of BSF and other private parties during demolition. If any such instances arise that shall be made up at the risk and cost of the bidder.
14. No transport or any other assistance shall be provided by BSF in demolition and shifting of debris. The disposal of debris are the sole responsibility of the bidder within the time prescribed in the notice.
15. In case of the successful bidder fails to deposit the cost of store on the spot, his earnest money shall be forfeited besides taking all other actions as deemed fit against the bidder.
