

1. All the interested bidders/parties are requested to attend the auction on scheduled date and time.
2. Each bidder must be in possession of Aadhar Card/PAN Card in original and same will be scrutinized by the board of officers, failing which they will not be allowed to participate in the auction.
3. All bidders will have to deposit Rs. 10,000/- (Rupees Ten Thousand) only as earnest money in shape of cash/demand draft in favor of Commandant, 38 Bn BSF, Sakawartuichhun, Aizawl (Mizoram), Which will be returned/adjusted after the auction.
4. GST will be charged as applicable from the successful bidders on the highest bid amount.
5. The successful bidder will have to lift the stores from Bn HQ Sakawartuichhun, 38 Bn BSF, Aizawl (Mizoram) under their own arrangement/supervision on same day. No Transportation will be provided by department/BSF for shifting/Lifting of auctioned stores.
