Further, if such a violation comes to the notice of Department, then I/We shall be debarred for tendering in BSF/CPWD in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-charge shall be free to forfeit the entire amount of the Earnest money /Performance Guarantee."

- h) The audited turnover of the bidder shall be minimum 10 Cr for the period of last three financial years till the date of publication of NIT. The same must be certified by Chartered accountant.
4. The original EMD should be deposited in the office of SE(ELECT) FHQ BSF N/DELHI / EE(ELECT) FTR HQ BSF M&C inviting bids within the period of bid submission i.e. on or before **25/06/2024**. Failing which bid submitted shall become invalid.
